TUITION TERMS & POLICIES

Registration is only complete (a space in the classroom is reserved for your child) when the \$75 registration fee (per child) accompanies this form. This fee is non-refundable.

Christ the King School uses the services of FACTS Tuition Management. All families must be enrolled with the FACTS Tuition Management Company and all tuition payments must be made through the practices of the company.

<u>Tuition rates are set based on anticipated support of Parish/School fundraisers and active volunteerism in the Parish/School Community.</u> The lack of such support will necessitate an increase in tuition rates.

I understand that if I fail to pay the tuition and other charges and fees set forth or do not meet other agreement requirements, I will be considered in default of this contract. In this event, the School shall attempt to work with me to resolve the default. If an agreeable solution cannot be found, the School reserves the right to ask me to remove my child(ren) from Christ the King School.

I agree to pay to the School the total tuition and other charges and fees for each of the enrolled students according to the schedule and terms that are set forth herein.

All Tuition payments are due on the 15th of every month, beginning in August. All tuition must be paid in full by May 15, 2026. We offer monthly, semi-annual, and annual payment options. Please select the payment option you would like from the choices below:
